Here are a few highlights over the past month:

- Since my last report, Marklund has received only **\$15K** from the State of Illinois. Our aging for Residential and Developmental Training, through August 31, stands at \$5.4M; this is almost \$1.5M more than last month. From a historical perspective, this is not unusual. We are monitoring this very closely to see if the State, now that they finally passed a budget, will be going back to the usual 120 day cycle. We currently have \$3.3M of our line of credit available.
- Thank you for the GREAT turnout for the Board Retreat. It seemed like everyone liked the more open format. I want to thank the following who carved a day out of their busy schedules to attend: **Jim Armbruster, Jeff Blanchette, Howard Brandeisky, Carie Carney, Maria Dombrowski, Carol Donahue, Gerry Estes, Duane Fitch, Dan Foley, Mike Herlihy, Brian Little, Frank Murnane, Jr.** (had a funeral to attend but made it to the Executive Committee), **Jeff Risch**, and **George Webster**.
- The wheels of the State turn very slowly but they finally came up with the distribution mechanism “rule” so that they could pass on the **75 cent/hour** pay raise that was approved as of July 1; the increase for the direct care staff was part of the **FY18 State Budget**. We are continuing to determine exactly “who” the State is defining as “direct care” but hope to be able to pass it on to the staff very soon.
- Congratulations to **George and Jeanne Webster** who have were unanimously approved by the Board as Marklund’s **2018 Friend of the Year!** The well-deserved honor will presented to them during Top Hat on February 3 at the brand new Marriott Marquis at McCormick Place.
- Congratulations to **Jeff Risch** who was recently named one of *The Best Lawyers in America 2018*. I want to also congratulate **Brian Little** who was interviewed last month by a prominent human resources publication for the “industry accolades [he has received] for his groundbreaking management training initiatives at global insurer Zurich.” I so appreciate the many talented board members that we are blessed to have at Marklund.
