Participation Agreement: The purchase/payment of any travel services offered constitutes a contractual arrangement between the Traveler ("you") and Viking Travel Service and its suppliers. As the lead traveler, you accept, and confirm you have authority and consent to accept, all Terms & Conditions for yourself and all members of your traveling party.

Upgrade/Insurance/Airfare Payments: All credit card charges are subject to 3% non-refundable fee. Make checks payable to Viking Travel, 700 E. Ogden Avenue, Suite 106, Westmont, IL 60559.

Documentation Required: Valid Passport –valid for 6 months from the return date. Names on reservations must match passports. Copy of passport required. Citizens of countries other than the U.S. - MUST contact the consulate of the country or countries being visited to determine visa requirements. It is the responsibility of the traveler to provide such documentation for booking and travel. Passports must be valid for a minimum of 6 months from the return date. All travelers must provide emergency contact details prior to travel.

Airline Reservations: Viking Travel Service is not responsible if an airline cancels, reschedules, or delays a flight for any reason. Routings are not guaranteed and are subject to change at any time. Seat assignments and upgrades may or may not be available and subject to additional fees.
